1. Apologies received from Cllr. Cartwright and Cllr Yarrow.
 2. Declarations of Interests – none received.
 3. SCDC seeks views and comments of the Parish Council on the Guided Busway – Discharge of condition 3(a)(iii) – Design and external appearance of Longstanton Guideway Junction.
Cllrs Johnston and Tucker visited the site on 29th April and outlined the layout of the area to the meeting.
Copy letters sent to SCDC by Mr & Mrs Ashby & Mrs E.Kides were circulated.

c) **S/0483/08/F** – Conservatory – 6 Stephenson's Road was discussed.
Cllr. Johnston proposed Approval without comment. Seconded by Cllr. Tucker. Unanimously agreed.
